**CONSTRUCTION OF

Sealed bids for the construction of **General Aviation Terminal Site Improvements** at the Office of the Harrietstown Town Clerk, 39 Main Street, Saranac Lake, New York 12983 on **Thursday, February 2, 2012 at 1:00 PM** local time, at which time and place all bids shall be publicly opened and read aloud. Bids submitted after this time shall not be accepted. Bids shall be submitted in a sealed envelope clearly marked, "**General Aviation Terminal Site Improvements Construction, Adirondack Regional Airport, NYSDOT PIN 7905.32.**"

The base bid project generally consists of the construction of a water system, site grading and underground infrastructure. The construction includes installation of a water plant approximately 6' x 6', connection from the existing well to the water plant, installation of two yard hydrants, a 3" water main service for future use, electrical pull boxes, conduit and duct banks, storm sewer installation, and site grading.

Add Alternate 1 generally consists of the construction of a partial asphalt access road approximately 1,025 linear feet by 24 feet wide. The construction includes installation of underdrain, storm sewers, clearing and grubbing, and embankment and related earthwork and site grading.

The project requires bonding and insurance to the contract amounts. The project is sales tax exempt. Site visits shall be coordinated with the airport manager by phone: 518-891-4600.

A complete set of Bid Documents, consisting of the General Provisions, Special Provisions, Technical Specifications, Bid, Agreement and Contract Drawings, will be available on **Friday, January 13, 2012**, and may be obtained from **Passero Associates at www.passero.com under the 'BID' tab** for a fee of **\$25.00 (Non-refundable)**.
